## COMMISSION OF HIS EXCELLENCY SIR G. F. BOWEN, G.C.M.G.

Commission passed under the Great Seal of the United Kingdom appointing Sir George Ferguson Bowen, G.C.M.G., to be Governor and Commander-in-Chief of the Colony of New Zealand.

Whereas We did by certain Letters Patent under the Great Seal of Our United Kingdom of Great Britain and Ireland, bearing date at Westminster the Twelfth Day of August, 1861, in the Grey's Commission, Twenty-fifth Year of Our Reign, Constitute and appoint Our Trusty and Well-Beloved Sir George Grey's Commission, 12th August, 1861, cited.

And further know you that We, reposing especial Trust and Confidence in the Prudence, Courage, and Loyalty of you the said Sir George Ferguson Bowen, of Our special Grace, certain Knowledge, and mere Motion, have thought fit to Constitute and Appoint, and by these Presents do Constitute and Appoint you to be Our Governor and Commander-in-Chief in and over Our Colony of New Zealand for each during Our Will and Placeure. And We de heaving and Commander in Chief in and over Our Colony of New Zealand. for and during Our Will and Pleasure. And We do hereby Authorize and Command you to Do and Execute all Things in due manner that shall belong to your said Command, and the Trust We have reposed in you, according to and in pursuance of an Act of the Session holden in the Ffteenth and Sixteenth Years of Our Reign, intituled "An Act to grant a Representative Constitution to the Colony Act 15 and 16 Victoria edited." and according to the several Powers and Directions granted or appointed you by this Our present Commission and the Instructions and Authorities herewith given you, or by such further Powers, Instructions, and Authorities as shall at any time hereafter be granted or appointed you under Our Sign Manual and Signet, or by our Order in Our Privy Council, or by Us through One of Our Principal Secretaries of State, and according to such Laws as are now or shall hereafter be in force in Our said Colony.

2. And Whereas it is expedient that an executive council should be appointed to assist you in the Administration of the Government of our said Colony: Now We do Declare Our Pleasure to be that there shall be an Executive Council for our said Colony, and that the said Council Executive Council, Constitution of. 2. And Whereas it is expedient that an Executive Council should be appointed to advise and shall consist of such Persons as you shall, by Instruments to be passed under the Public Seal of Our said Colony in Our Name and on Our Behalf, from time to time Nominate and Appoint to be Members of the same.

3. And We do hereby Authorize and Empower you to Keep and Use the Public Seal for Sealing Public Seal.

4. And We do hereby Authorize and Empower you to Make and Execute in Our Name and on Our Behalf, under the Public Seal of Our said Colony, Grants and Dispositions of any Lands which Grants of Land.

And we do further Authorize and Empower you to Constitute and Appoint Judges, and in Appointment of Judges and Judges cases requisite, Commissioners of Oyer and Terminer, Justices of the Peace, and other necessary Officers and Ministers of Our said Colony of New Zealand, for the due and impartial Administration of Justice, and for putting the Laws into execution.

6. And We do hereby Authorize and Empower you as you shall see occasion, in Our name and on Our Behalf, to grant to any Offender convicted of any Crime in any Court, or before any Judge, Grant of pardons Justice, or Magistrate within Our said Colony, a Pardon, either free or subject to lawful conditions, or and remission of fines. any Respite of the Execution of the sentence of any such Offender for such period as to you may seem fit; and to remit any Fines, Penalties, or Forfeitures which may become due and payable to Us.

7. And we hereby Authorize and Empower You, so far as We lawfully may, upon sufficient cause to you appearing, to Remove from his Office, or to suspend from the exercise of the same, any Person suspension or reexercising any such Office or Place within Our said Colony, under or by virtue of any Commission or Warrant granted or Which may be granted by us in Our Name, or by Our Authority.

8. And Whereas it has been represented to Us, that the Necessities of Our Service in Our said

Colony occasionally require that you should Absent yourself from the Seat of Government in the Province of Wellington, whereby the Affairs of the said Province might be exposed to detriment if there were no Person in the place who should be Authorized to exercise the Powers and Authorities which We have by this Our present Commission given and granted to you, Our Governor: Now We do hereby Authorize and Empower you, from time to time, as occasion shall require, by an instrument under the Public Seal of Our said Colony, to Assign, Constitute, and Appoint any Person to be your Governor may appoint in the said Province of Wellington, and in that capacity to Exercise, Perform, and Execute uning your Pleasure, but no longer, all such Powers, Directions, and Authorities as are vested in you by this Our Commission and the Instructions under Our Sign Manual and Signet herein referred to.

SeatofGovernment. Provided Nevertheless, that by the appointment of a Deputy, as aforesaid, your Power and Authority as Governor of Our said Colony, shall not be abridged, altered, or in any way affected, otherwise than We may at any time hereafter think proper to Direct.
