

In accordance with an Order of the House of Representatives made the 25th day of August last, I have the honor to enclose a statement showing the proceedings of the Native Land Court for the year ending the 30th June, 1868.

With respect to the latter part of the Order, I have the honor to inform you that I cannot find that any formal reports have been recently made by myself or any of the Judges, nor that any have been asked for. I have been unwilling myself to volunteer any statement of opinion, for I could not fail to observe that Parliament, in the Native Land Act which they passed last Session, seemed inclined to legislate in direct opposition to what I had stated, in my report then made, to be, in the opinion of myself and the other Judges, the politic and just course.
