His Honor O. CURTIS to the Hon. W. GISBORNE.

Superintendent's Office, Nelson, 20th January, 1872.

I have the honor to acknowledge the receipt of your letter of the 4th December last, forwarding a copy of "The Payments to Provinces Act, 1871," and informing me that the Government had decided to pay, for the two quarters ending 30th September and 31st December, 1871, at the rate of one-half the amount allotted to each Province out of the total sum of £100,000, reserving the other half until the Minister for Public Works and myself should have decided, in conformity with the provisions of the 28th section of the Act, what portion of the reserved half is to be devoted to permanent public works within the Province, authorized by an Act of the Superintendent and Provincial Council.

You proceed to direct my special attention to the 19th section of the Act, which renders it imperative that I should hold in reserve one-tenth of the sum allotted to the Province for Road Boards not yet in existence, but which may be established before the 1st July next, as well as to the reservation of three-elevenths, directed by section 29, to be made for Road Boards to be

hereafter established in the Nelson South-west Gold Fields.
