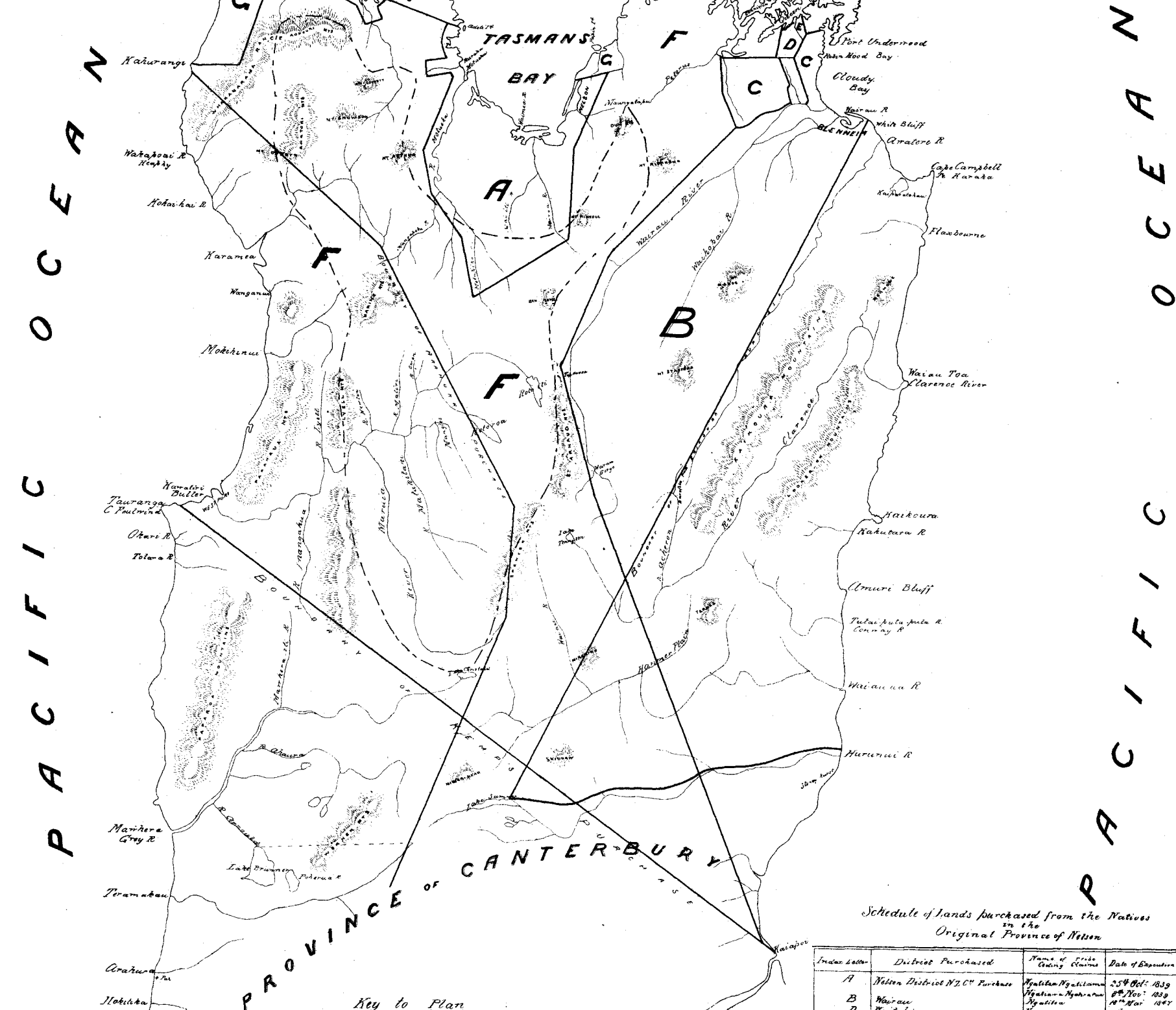

C	Land excepted from Sale out of the Wairau Block by the Ngaitara tribe in March 1857 but subsequently included in the final Sale to the crown in August 1855
D	Waitohi Purchase
E	Land reserved for the Natives adjacent to Waitohi Block
F	Waipounamu Block & subsequent purchases
G	Land excepted from Sale out of the Waipounamu Block at Karapuna, Tirohanga Island and Mt Whangamau at the final extinguishment of Native claims in 1855, 6
H	Pakarua Purchase
I	Separation Point
J	Block of Land intervening the Pakarua purchase and land sold by the Ngaitara and Ngaitara tribes to the Government in November 1855 for which Koroa Tuarangi subsequently received value to the extent of £100 from the Government in the shape of 1 pair of Bullocks, 2 cows, a cart, and a plough

Note The land included within the blue line on the East and the red on the West Coast, indicates the territory acquired from the Ngaitara tribe within the boundaries of former Purchases
The land included within the dotted line — — — is the Country now claimed by the Natives
