Throughout the past year the arrangement of school quarters in both colleges agreed to by the Governors in May, 1884—which abolished the former system, under which the quarters were reckoned by the months of the year, regardless of the long vacation at Christmas, and which provided that each quarter should for the future consist of about seventy days, the first beginning on the 1st February in each year instead of on the 1st January—has been in operation; and the avoidance of what was known as the "short quarter" has given general satisfaction to parents.

The term of office of some of the Council of Governors having expired during the year 1885, and other changes having occurred in consequence of resignations, the Governors think it desirable to append a statement of the present position of the governing body of the college, which is constituted as follows: Hon.
