ABSENTEE LANDED PROPRIETORS

(RETURN OF) OWNING MORE THAN 2,000 ACRES.

Return to an Order of the House of Representatives, dated 11th November, 1887.

Ordered, "That a return be laid upon the table of all persons owning more than 2,000 acres of land in New Zealand who are not known to have resided in the colony at any time during the last twelve months."—(Mr. W. P. REEVES.)
