It will be noted that several papers which in past years have been included in the series set out below are not included on this occasion. Their omission was decided upon on the grounds of the paper shortage and their relative importance. Their reappearance in the series at some future date cannot at present be definitely stated. Paper shortage also accounts for the severe curtailment of the size of reports and other printed matter, and all are included in the one volume.
