Extracts from the Journals of the House of Representatives

WEDNESDAY, THE 3RD DAY OF MARCH, 1943

Ordered, "That the Osteopathic Practitioners Bill be referred to the Public Health Committee."—(Mr. McKeen.)

THURSDAY, THE 4TH DAY OF MARCH, 1943

Ordered, "That a Select Committee be appointed, consisting, by leave, of fourteen members, to consider all matters relating to public health, infectious diseases, contagious diseases, hospitals, and to local authorities having charge of these matters, and to other matters affecting public health which may be referred to it: the Committee to consist of Mr. Acland, Mr. Anderton, Mr. Boswell, the Hon. Mr. Cobbe, Mr. Coleman, Mrs. Dreaver, Mrs. Grigg, Mr. Kyle, Dr. McMillan, the Hon. Mr. Paikea, Mr. Richards, Mr. Roy, Mrs. Stewart, and the Mover."—(Hon. Mr. NORDMEYER.)

FRIDAY, THE 5TH DAY OF MARCH, 1943

Ordered, "That all petitions not finally dealt with during the session of 1941-42 be again referred to the same Committees as they were referred to during the said session."—(Right Hon. Mr. Fraser.)

THURSDAY, THE 20TH DAY OF MAY, 1943

Ordered, "That Select Committees have leave to sit for the remainder of the session on days on which the House does not meet."--(Right Hon. Mr. FRASER.)

WEDNESDAY, THE 4TH DAY OF AUGUST, 1943

Ordered, "That the Public Health Committee have leave to sit during the sitting of the House on Thursday, the 5th day of August."—(Mr. Anderson.)

No. 69/1941.—Petition of L. F. Roache, of Wanganui

Praying for compensation for alleged neglect of treatment in hospital.

OSTEOPATHIC PRACTITIONERS BILL

I have the honour to report that the Public Health Committee has heard considerable evidence on, and has carefully considered, the Ostcopathic Practitioners Bill, and recommends that it be not allowed to proceed.

The Committee, however, desires to express the opinion that the Government should introduce a Bill securing a measure of control over persons professionally engaging in the practice of healing, other than those already recognized in New Zealand by statute.
