## ORDERS OF REFERENCE

Extracts from the Journals of the House of Representatives

FRIDAY, THE 8TH DAY OF JULY, 1949

Ordered, "That a Select Committee be appointed, consisting, by leave, of fifteen members, to consider all petitions, reports, returns, and other documents relating to affairs especially affecting the Maori race which may be referred to it, and from time to time to report thereon to this House: the Committee to consist of Mr. Cotterill, Mr. Kearins, Mr. Langstone, Mr. Maher, Mr. Massey, Mr. Murdoch, Mr. Omana, Mr. Osborne, Mr. Paikea, Mr. Ratana, Mr. Sim, Mr. Smith, Mr. Sullivan, the Hon. Mr. Tirikatene, and the mover."—(Right Hon. Mr. Fraser.)

Ordered, "That all petitions not finally dealt with during the session of 1948 be again referred

to the same Committees as they were referred to during the said session."—(Right Hon. Mr. Fraser.)

TUESDAY, THE 18TH DAY OF OCTOBER, 1949

Ordered, "That the Maori Purposes Bill be referred to the Maori Affairs Committee," -(Right Hon. Mr. Fraser.)
