I have the honour to inform you that His Royal Highness the Duke of Cornwall and York inspected the veterans of the Imperial army and navy at each of the four centres of the colony.

2. His Royal Highness pointed out to me the very worn state of most of the medal ribbons, and that in many cases the wrong coloured ribbons had been attached, these old servants of the Crown having been unable to obtain in this colony ribbon of the proper pattern.

3. His Royal Highness desired me to state the facts, and apply for the

proper material.

4. I have the honour, Sir, to request that you will move the Secretary of State for War to grant a supply of these ribbons, which would be distributed through the Veteran Associations to those holding the proper medals.

5. I estimate that there are not less than 2,000 of these Imperial Veterans

who all saw active service prior to the year 1865.
