Return to an Order of the House of Representatives dated the 21st August, 1903.

Ordered, "That there be laid before this House a return showing—(1) the present value of all Maori lands in the South Island under the most recent valuation; and (2) the names of the individual owners and the number of each section owned by them, commencing at Kaikoura and extending to Rakiura and Ruapuke."—(Mr. PARATA.)
