TARATA DOMAIN.

Section No. 58, Tarata Village. Area, 8 acres 2 roods.

Work done during year: Fences repaired, hedges trimmed and cleaned, willows planted along river-bank, and running-track constructed. Improvements now on domain: Sheep-proof fences, tennis-court, plantation, pavilion, and running-track. Used for sports, tennis, and picnics.

TAUMATA DOMAIN.

Subdivisions Nos. 1 of Section No. 12, and 6 of Section No. 75, Block X, Ngaire Survey District.

Area, 12 acres 1 rood 5.3 perches.

Work done during year: Large grandstand, to seat five hundred people, with luncheon-rooms underneath, erected; dressing-shed provided, new gate erected, racing-track graded and re-formed, fences moved and added to, areas ploughed and grassed, and plantations kept in order. Improvements now on domain: Two grandstands, luncheon-rooms, dressing-shed, fences, plantations, water-supply, ploughing, and grassing. Used for sports and picnics. Preston Street, Eltham, has been extended to the southern boundary of the reserve, thereby enhancing its value and providing another means of access.

TE NGUTU-O-TE-MANU DOMAIN.

Section No. 40, Block XVI, Kaupokonui Survey District. Area, 50 acres.

Work done during year: Shelter-shed erected, and buildings, &c., painted. Improvements now on domain: Box-thorn hedges, post-and-wire sheep-proof fences, caretaker's cottage, seats, iron and wooden gates, turnstile, dam and pond, plantation, monument, shrubbery, shelter-shed, native bush, and 4 acres pasture. Used for picnics. Proposed operations for ensuing year:

TOKO DOMAIN.

Part of Section No. 36, and part of Subsection 1 of Section No. 36, Block III, Ngaire Survey District. Area, 7 acres 31 perches.

Work done during year: Thirteen chains sheep-proof fences and 15 chains ordinary fences erected; the whole area stumped; 4 acres ploughed, levelled, and grassed; tracks formed; bridge and gate erected; and two hundred trees and shrubs planted. Improvements now on domain: Fifty chains fences, two hundred trees and shrubs, bridge and gate. Used for cricket, sports, football, and picnics. Proposed operations for ensuing year: Formation of running-tracks and concrete cricket-pitch, and erection of 23 chains sheep-proof wire-netting fences.

URENUI DOMAIN.

Section No. 12, Block III, Waitara Survey District. Area, 57 acres.

Work done during year: Extending and repairing drain for reclaiming swamp. Improvements now on domain: Fences, drains, plantations, swing bridge. Proposed operations for ensuing year: Planting sand waste, and repairing swing bridge.

URUTI DOMAIN.

Section No. 8, Block II, Upper Waitara Survey District. Area, 10 acres 3 roods 16 perches.

Work done during year: Gate and 26 chains good fences erected, and 4 acres cleared of scrub and grassed. Improvements now on domain: Fences, gate, and grassing. Proposed operations for ensuing year: Further clearing, to make sports-ground and plantation.

WAIPURU DOMAIN.

Sections Nos. 45, 47, 49, and 51, Waipuku Village. Area, 2 acres and 12 perches.

Work done during year: Planting live fence, and protecting same with barbed-wire fence. Improvements now on domain: Fences. Used chiefly for grazing.

WELLINGTON LAND DISTRICT.

ALFREDTON DOMAIN.

Section No. 201, Block XII, Mangaone Survey District. Area, 100 acres.

Work done during year: About 44 chains drains constructed, and fencing-material obtained. Improvements now on domain: Nearly all ring-fenced, about 12 chains box drain and 32½ chains pipe drain, shed and fixtures, boundary and subdivisional fences, and 1 acre planted with trees and shrubs. Used for sports, cricket, and picnics. Proposed operations for ensuing year: Tree-planting and erection of more fences.
