No objection was advanced to this claim for inclusion, and the said thirty-four names are set out in the additional list of owners attached to the file of papers for Ruatoki South Block, and

We recommend that the said thirty-four names be added to the order with shares as shown.

Appeal No. 52.—By Waaka Paraone te Ranui and others, asking for the inclusion of four new names in the order.

There is no objection advanced to the inclusion of these four persons in the order as shown in the list of names attached to the file and therein numbered from 315 to 318, inclusive, with shares as shown.

We recommend that these four names be added to the order.

Appeal No. 57.-By Mehaka Tokopounamu and others, for inclusion of certain new names in the order.

By arrangement made between the owners of the land and the appellants outside, and subsequently submitted by them to this Commission, twenty-four names were agreed to be included by the owners from the list submitted by the appellants, Numia Kereru and others on behalf of the owners objecting to the balance of the names originally submitted by Mehaka in his list for inclusion. Mehaka then agreed to abandon his claim for inclusion of the remaining persons in his list, and accept inclusion of the twenty-four names only agreed to by the owners. The said twenty-four names have therefore been added by this Commission to the list of additional owners attached to the file, and therein numbered respectively from 319 to 342, inclusive.
