The Government recently took possession of a small section of land on Wellington Terrace, immediately opposite the Wellington Club, which is now required in the interests of improvement by the City Council. The Council are desirous of creating a low-level street in Woodward Street, running from Lambton Quay to Wellington Terrace, and making the present portion of Wellington Terrace in that quarter practically a high-level street. To accomplish this it is necessary that

the Council should absorb some 4 or 5 perches of the present section at the corner of Woodward Street. This would, however, mean so serious a loss of space as to make the compensation to be paid by them very heavy, and possibly prevent the improvement taking place. This, however, could be avoided if the Council were in the position of being able to transfer to the owner of the corner section a section of somewhat similar size and value—the one recently vested in the Government.

We shall, therefore, be glad to know if the Government would assist the matter by placing a fair price upon the latter section, when the City Council and the owner could adjust the matter, and a very necessary public work be made possible.
