Return to an Order of the House of Representatives dated the 28th September, 1911.

Ordered, "That there be laid before this House a Return showing—(1) The gross public debt at the 31st March, 1911: the Return to show separately the debt under the State-guaranteed Advances Act and other debts; (2) the accumulated sinking funds, both for the State-guaranteed and other debts, and the net debts of each; and (3) the total gross debt of the Dominion, the total accumulated sinking funds, and the total net debt."—(Mr. ALLEN.)
