ORDER OF REFERENCE.

Extract from the Journals of the House of Representatives.

FRIDAY, THE 20TH DAY OF JULY, 1917.

Ordered, "That Standing Order No. 219 be suspended, and that a Select Committee be appointed, consisting of fifteen members, to whom shall stand referred, after the first reading, all Bills affecting or in any way relating to lands of the Crown or educational or other public reserves; the Committee to have power to make such amendments therein as they think proper, and to report generally when necessary upon the principles and provisions of the Bill; the Committee to have power to call for persons, papers, and records; three to be a quorum: the Committee to consist of Mr. Anderson, Mr. Anstey, the Hon. Mr. Buddo, Captain Coates, Mr. Forbes, Mr. Guthrie, Mr. Jennings, Mr. E. Newman, Mr. Nosworthy, the Hon. R. H. Rhodes, Mr. T. W. Rhodes, Mr. R. W. Smith, Mr. Statham, Mr. Witty, and the mover."—(Right Hon. Mr. MASSEY.)
