

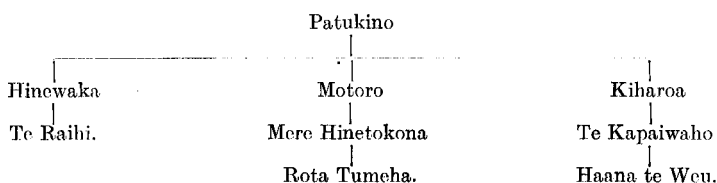
SUCCESSION TO TE RAIHI TE URI IN MANGOREWA-KAHAROA NO. 6E SECTION 3 NO. 2.

ROTA TUMEHA (sworn): He died July, 1906. No issue. Left cousin. I can give the relationship:—

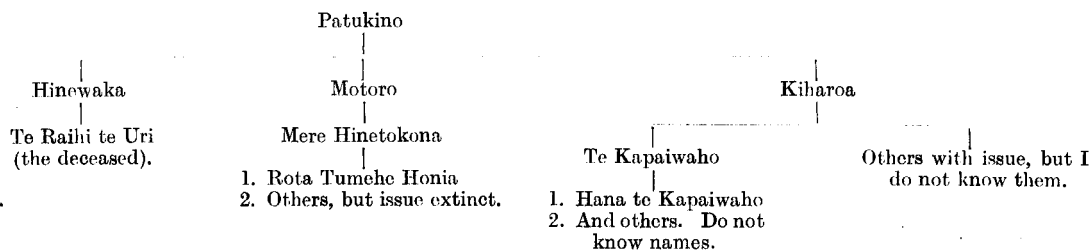
Mangorewa-Kaharoa No. 6E.—Te Raihi te Uri (deceased).

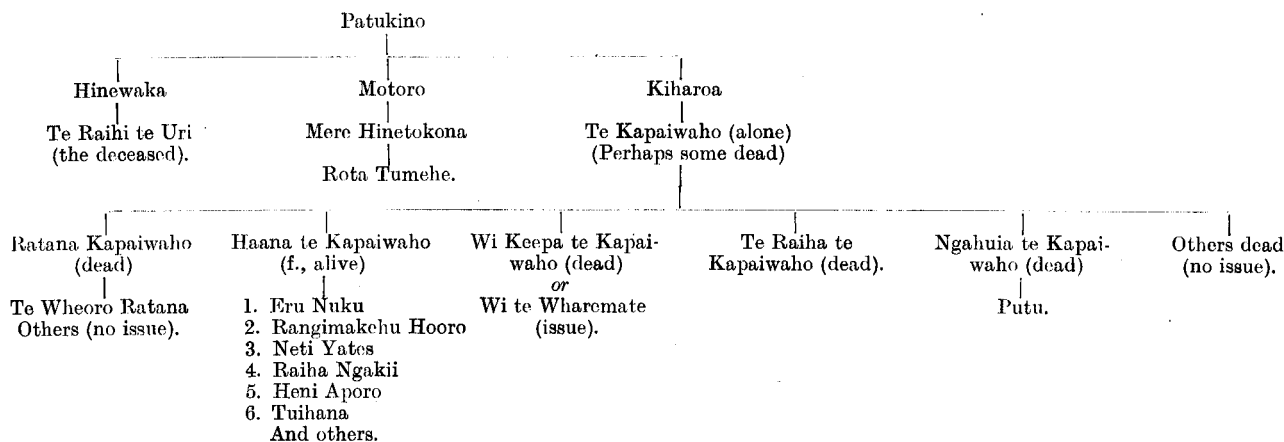
ROTA TUMEHE HONIA (sworn): Te Raihi te Uri died in 1906. Left no will. He left no issue. His right came from Patukino. I will trace:—



I am in succession order for one-eighth share. I say I ought to get one-half. The shares in first order were right, but I was not present on the 17th March, 1908, when the Court altered the names and shares.

TAUHU KINGI: No questions.

TAUHU KINGI (sworn): The successors were arranged by successors of Kapaiwaho. The land came from Patukino. I will trace:—
