The Right Hon. the PRIME MINISTER to the CHAIRMAN OF THE COMMITTEE. Prime Minister's Office, Wellington, 30th July, 1920.

DEAR SIR,

I have to inform you that the Government is exceedingly anxious, in view of the conditions existing in this country at present, and the necessity for arriving at a proper understanding in regard to getting our products away from the Dominion to the different markets of the world, that the Agricultural and Pastoral Industries, Stock, and Commerce Committee should take in hand an inquiry-firstly, as to whether sufficient shipping is likely to be available for the purpose of our trade, especially the export of our produce, during the next few years; and, secondly, to arrive at a definite understanding with the shipping companies as to what the rates of freight are likely to be, especially for wool, meat, dairy-produce, and flax.

The Committee has power to call for persons and papers, and you will, of course, take into consideration increases in wages and cost of coal, and, generally, the cost of running ships as

compared with the pre-war period.

I shall be glad if you will let me know what you think of this proposal.
