FINAL REPORT.

I have the honour to report that the Native Affairs Committee held its final meeting on Thursday, the 2nd day of February, 1922.

During the session the Committee met on 44 occasions, with an average attendance of 8.

Including 77 petitions brought forward from the session of 1920, and 11 from the first session of 1921, the Committee had before it 173 petitions. Of these petitions 112 were considered and reported upon, and the remaining 61 are held over until next session. With regard to 28 petitions the Committee recommended that they be referred to the Government as follows: 4 for favourable consideration, 16 for inquiry, and 8 for consideration. With regard to 2 petitions the Committee recommended that they be referred to the Hon. the Native Minister. Upon 64 petitions the Committee had no recommendation to make, and 18 petitions were withdrawn.

The Native Trustee Amendment Bill, the Native Land Amendment Bill, Part IX and the

definition clauses relating thereto of the Samoa Bill, the Cook Islands Amendment Bill, Part VI of the Forests Bill, the Native Land Amendment and Native Land Claims Adjustment Bill, and the Urewera Lands Bill were referred to the Committee, and were duly considered and reported upon.

One parliamentary paper of the first session of 1921, and 11 of this session, were referred to the Committee, and were duly considered and reported upon.

The total number of reports presented to the House was 132.
