I am directed to report that in the opinion of the Committee this petition should be recommended to the Government for inquiry so far as the ownership in the Kekerione Block is concerned as stated in clause 5 of the petition, but excluding the Moriori title to other lands; and, further, the Committee recommends to the Government that the necessary legislation should be enacted to enable this particular inquiry to be made. The Committee recommends that this report be referred to the Government for favourable consideration.
