ORDER OF REFERENCE.

Extract from the Journals of the House of Representatives.

TUESDAY, THE 15TH DAY OF MARCH, 1938.

Ordered, "That the Education Committee have power to sit during the recess and for fourteen days after the commencement of the next session at such times as the Committee may see fit, with power to consider the principles and provisions of the Education Amendment Bill to be introduced this session, both generally and in relation to the principal Act: the Committee to report to the House before the expiration of fourteen days after the commencement of next session, and to have power meantime, where it thinks fit so to do, to advise the Government from time to time on any of the aforementioned matters."—(Hon. Mr. FRASER.)
