expenditure by local authorities in connection with the King George V Memorial Fund, the Coronation Celebrations, the New Zealand Centennial Exhibition, and, in the case of Rabbit Boards, the destruction of rabbits on private lands, but as in each case the necessary provision was subsequently made by legislation they have been omitted from the schedules.
