ORDERS OF REFERENCE.

Extracts from the Journals of the House of Representatives.

TUESDAY, THE 1ST DAY OF AUGUST, 1939.

Ordered, "That a Select Committee be appointed, consisting of ten members, to whom shall stand referred, after the first reading, all Bills affecting or in any way relating to the lands of the Crown, or education or other public reserves; the Committee to have power to recommend such amendments therein as it thinks proper, and to report generally, when necessary, upon the principles and provisions of the Bills: the Committee to consist of Mr. Boswell, Mr. Cullen, Colonel Hargest, Mr. Kidd, Mr. McCombs, Mr. Meachen, the Hon. Sir Alfred Ransom, Mr. Roberts, Mr. Williams, and the Mover."—(Hon. Mr. LEE MARTIN.)

WEDNESDAY, THE 2ND DAY OF AUGUST, 1939.

Ordered, "That the name of Mr. McCombs be discharged from the Lands Committee, and that of Mr. Combs substituted therefor."—(Hon. Mr. LEE MARTIN.)

THURSDAY, THE 3RD DAY OF AUGUST, 1939.

Ordered, "That all petitions not finally dealt with during the session of 1938 be again referred to the same Committees as they were referred to during the said session."—(Hon. Mr. FRASER.)

WEDNESDAY, THE 23RD DAY OF AUGUST, 1939.

Ordered, "That the Lands Committee have leave to sit during the present sitting of the House."—(Mr. WILLIAMS.)

THURSDAY, THE 14TH DAY OF SEPTEMBER, 1939.

Ordered, "That the name of the Hon. Mr. Lee Martin be discharged from the Lands Committee, and that of the Mover substituted therefor."—(Hon. Mr. LANGSTONE.)

WEDNESDAY, THE 20TH DAY OF SEPTEMBER, 1939.

Ordered, "That the Lands Committee have leave to sit during the present sitting of the House."—(Mr. CULLEN for Mr. WILLIAMS.)

FRIDAY, THE 22ND DAY OF SEPTEMBER, 1939.
